OPENING

- 1. SPF will provide all labor to clean and fill the fountain.
- 2. SPF will reassemble the fountain equipment to include pumps, filters and other devices associated with the operation of the fountain.
- 3. SPF will balance the water chemistry to normal industry standards.
- 4. SPF will commence fountain operations and set time clocks as directed by the property owners or managers.
- 5. SPF will test all fountain operations and notify owner of any repairs needed.

MAINTENANCE VISITS

- SPF will provide all labor and equipment needed to remove debris from the fountain floors and walls. (*)
- 2. SPF will balance the water chemistry to normal industry standards.
- 3. SPF will test all fountain operations and notify owner of any repairs needed.
- (*) Fountains that are not equipped with filter systems or that have shallow water levels less than 12", may need to be drained and cleaned occasionally to fully remove small debris. Draining and cleaning is not included in this contract price unless specifically stated.

CLOSING

- SPF will provide all labor and equipment needed to drain the fountain as appropriate for the winter.
- 2. SPF will drain all filters and pumps as appropriate. SPF will blow and plug lines as needed.
- 3. SPF will notify owner, in writing of any necessary procedures or circumstances that may need to be monitored for the winter.
- 4. SPF includes all chemicals required for the standard adjustment of chlorine, pH, calcium hardness and alkalinity.
